WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

I, _____, acknowledge and understand that offroading is a dangerous activity and has inherent risks, hazards, and dangers for anyone, which cannot be eliminated, particularly on the trail. I understand that these risks, hazards, and dangers include, without limitation, the risk of handling firearms and being near others who have firearms in their possession, the risk of injury from ammunition and shot from other guns, walking in rugged country, including encounters of wildlife, animals and insects, and inclement weather conditions.

I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE RDY2ROK Offroad, LLC, its Members, Managers, officers, agents, associates, or employees and the landowner, its agents, associates, or employees from any and all liability, claims, demands, actions and causes of actions arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any property belonging to me, whether caused by my negligence, the negligence of the releasees, or any others negligence, or while in, on, upon, or traveling or responding to or from the premises or location where the activity is being conducted. I am fully aware of the risks and hazards associated with offroading.

I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged in such activity. I further hereby AGREE TO HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that may incur due to my participation in said activity, WHETHER CAUSED BY MY NEGLIGENCE, THE NEGLIGENCE OF THE RELEASEES, AND ANY OTHER PERSONS NEGLIGENCE, or otherwise.

It is my intent that this RELEASE AND HOLD HARMLESS AGREEMENT shall bind the members of my family and spouse, and any of my heirs, assigns and personal representatives, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND NOT TO SUE the above named RELEASEES. I further agree that this WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT shall be construed in accordance with the laws of the State of New Mexico.

BY SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the Waiver of Liability and Hold Harmless Agreement, I also understand and sign it voluntarily as my own free act; no oral representations, statements, or written agreement, have been made; AS I HAVE NOT OBTAINED THE AGE OF EIGHTEEN (18) YEARS, MY PARENT OR LEGAL GUARDIAN HAS EXECUTED THIS RELEASE ON MY BEHALF.
